### POSITION SUMMARY:

This position supports the work of the Y, a leading nonprofit committed to strengthening community through youth development, healthy living and social responsibility. Instructs group classes in a safe, enjoyable, and positive environment that welcomes people of all skill and fitness levels. Effectively builds community within the class. Modifies class as needed to meet varied health, ability and cultural needs.

### ESSENTIAL FUNCTIONS:

1. Leads and instructs private/ group classes, as directed by the supervisor, to accomplish the YMCA mission and goals.
2. Teaches proper technique.
3. Is prepared with lesson plans and technicality.
4. Builds effective, authentic relationships with students; helps students connect with each other and the YMCA.
5. Keeps accurate class attendance records.
6. Is on time to classes and gives plenty of notice if a class must be missed.
7. Uses clean and age appropriate music.
8. Follows YMCA policies and procedures; responds to emergency situations.
9. Performs other duties as assigned.
